

Official Rules:

"Share Gluten-Free Pizza with Friends Giveaway"

The information you provide will be used for administering and communicating with you about Etalia Foods and the Etalia Foods promotion you are participating in.

ELIGIBILITY: Etalia Foods Share Gluten-Free Pizza with Friends Giveaway (the "Contest") is open to entrants ages 18.

Entrants must be residents of the United States with access to the Internet during the Contest Period for online entry and subsequent prize-award period for winner notifications.
